REQUIREMENTS AND PROCEDURES of the Schroeder Scholarship Program

Eligibility

In order to receive the Schroeder Scholarship you must:

- be a minimum of an Associate Member in good standing of the Chicago Chapter at time of application
- have demonstrated a desire to pursue the MAI designation
- follow the current applicable designation path requirements of the Appraisal Institute.
- have not received a scholarship award within one year preceding the date of your application.

Requested Documentation

Complete signed application/letter of agreement

Submit copies transcripts of prior education and any educational degree(s)

Submit copies of certificates of attendance of appraisal education courses

Submit a copy of your Illinois State Appraisal License

Submit a letter of recommendation from an appraisal professional.

Agree to attend a minimum of two Chicago Chapter meetings or functions during the twelve month period of my scholarship award.

Elective

Submit a letter of recommendation from an appraisal professional. (This letter is elective, but if submitted will be given additional consideration in the committee’s final award decision.)

Awards

The award represents the current published cost of tuition and course materials of any one selected course required by your designation path criteria and offered by the Chicago Chapter, with completion of award within one year of notification date. Award may not be used solely to satisfy State of Illinois Continuing Education requirements or any class required by the State of Illinois for disciplinary reasons.

Award Payment

The Education Trust will pay your cost of tuition and course materials directly to the Chicago Chapter of the Appraisal Institute and not to the individual student.

Application Process

Complete and submit the Application and Agreement prior to the 1st day of March of the year for which you are applying for a scholarship award to the Chicago Chapter of the Appraisal Institute. All portions of the application must be complete and all information supplied must be accurate.

Re-examination

Re-examination fee will not be paid by the scholarship funds. The recipient will be responsible for re-examination fees and award funds cannot be used to repeat any course.
